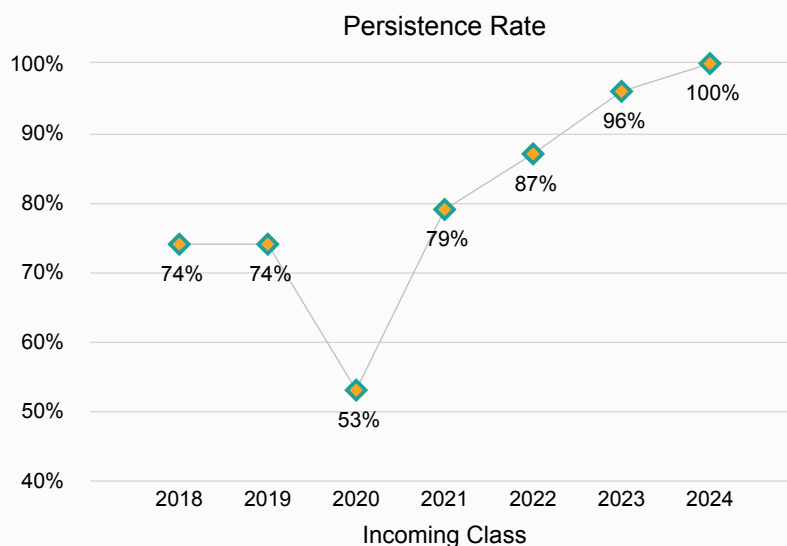
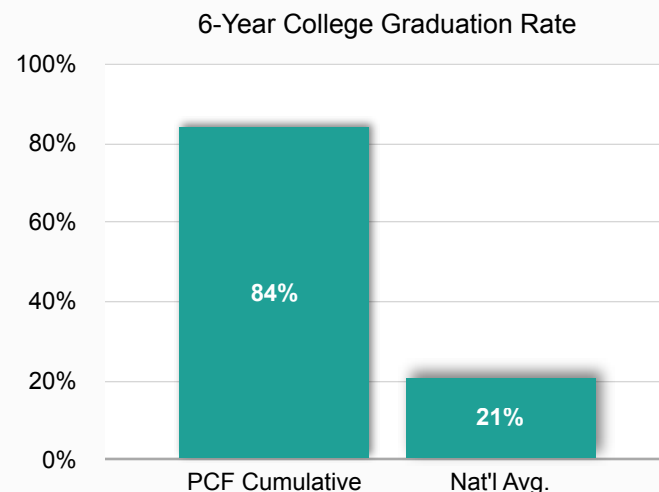
Success in College

College success for PCF scholars can be measured by their persistence and 6-year graduation rate. Nationally, only 21% of low-income, first-generation students who start at any 2-year or 4-year college graduate within six years*, compared to 84% of PCF scholars. PCF's persistence rate, the rate at which students return to an institution of higher education the following year, has rebounded since the COVID-19 pandemic to 91%.

COVID-19 caused unprecedented obstacles for PCF's first-generation, low-income scholars. During their critical, early college years the abrupt transition to remote learning led to significant academic learning loss and lack of access to essential on-campus resources such as tutoring, mental health services, and food security programs on which many PCF scholars rely. This disruption was exacerbated by financial pressure typical of low-income students. When family members became sick or lost jobs during the pandemic, many scholars increased their working hours or withdrew from college entirely to provide financial support to their families, severely impacting their ability to persist in college. Lastly, we saw that social isolation and the loss of our scholars' crucial on-campus community likely contributed to higher rates of mental health struggles and attrition, also impacting college persistence and completion rates.

Despite these obstacles, PCF remains committed to strengthening the college, career, and social-emotional support our scholars receive, through individualized advising services, 1-1 mentor support, and college and career training to ensure they graduate with a Bachelor's degree and develop the skills necessary to obtain a career that aligns with their goals.

"I've always been drawn to the legal field, but as a first-generation college student, I had no clear roadmap for how to get there. Graduating from college was my first major milestone and it truly wouldn't have been possible without The Peninsula College Fund. Both opportunities allowed me to see the law's impact from different angles, helping those wrongfully convicted and supporting local government initiatives.

Now, as I approach graduation from Santa Clara University School of Law, I'm preparing to begin my career as an associate at Womble Bond Dickinson. The opportunities I have today are the result of the resources, mentors, and community who believed in me and invested in my growth. The Peninsula College Fund was one of the first to do that, and its impact has stayed with me every step of the way."

Training

College Success Collaborative Conference

Through a partnership with the College Success Collaborative and nine other Bay Area organizations, this year's conference created an engaging space for our scholars to connect with more than 300 first-generation college students. Participants attended a range of interactive workshops focused on financial literacy, career exploration, mental health, and other key topics.

At the 2025 conference, PCF Scholars represented one-third of the total attendees. They heard inspiring keynote addresses from Dr. Al Camarillo and Jeff Camarillo of Stanford University and enjoyed a special musical performance by Megan Keely. In addition, PCF sponsored professional headshots for all participants, providing students with a fresh opportunity to enhance their LinkedIn profiles. Scholars highly valued the experience, gaining new insights and motivation to guide them in their academic and career journeys.

College Kickoff: Freshman Experience

In 2025, PCF launched our first-ever College Kickoff event, held June 21–22 at Santa Clara University. The two-day event brought together new scholars, mentors, and families for a dynamic series of programs, including our New Mentor and New Scholar Orientation, the annual Awards Ceremony honoring both our incoming scholars and graduating seniors, and the Freshman Experience, a full day recently redesigned to prepare students for a successful first year in college.

We kicked things off with Orientation, where incoming scholars and their families were welcomed alongside new mentors. Before mentors and scholars enjoyed lunch together and began building the foundation for their new mentoring relationships, separate sessions provided tailored information for each group: mentors were trained on their role and expectations over the next 4+ years; parents received guidance on how to best support their students through college; and students were introduced to PCF's programs, resources, staff, and support systems.

Following Orientation, we celebrated academic milestones at our Awards Ceremony, recognizing our outgoing graduates onstage before welcoming our newest class of scholars. It was truly an honor to recognize the accomplishments of both groups!

On Sunday, incoming students returned for the Freshman Experience, a full day of alumni- and student-led workshops, training, and team-building activities. Topics included financial literacy, preparing for the freshman year, comparing campus living versus commuting, and overcoming imposter syndrome. Between sessions, students participated in fun and interactive activities such as a water balloon toss, scavenger hunt, and team challenges, helping them bond with peers, especially those attending the same college.



Internships and Careers



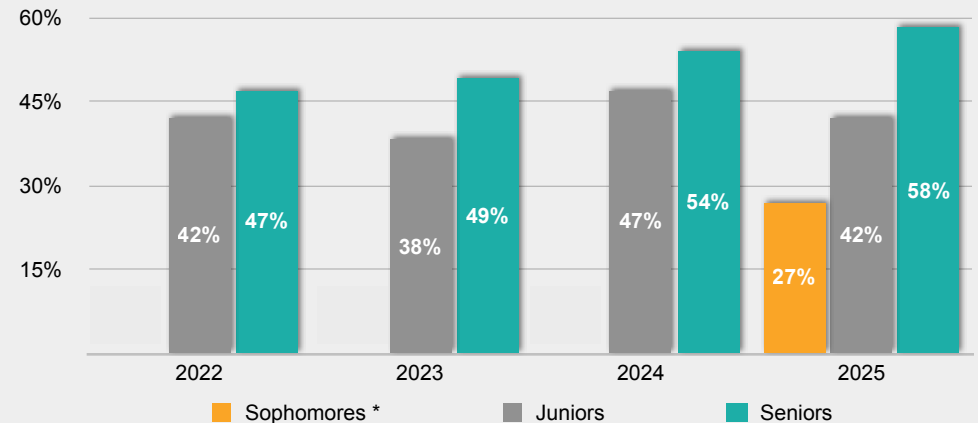
"I remember anxiously applying for internships left and right for months. I was met with constant rejection; however, I stayed diligent. I received emails and text messages from PCF announcing an internship opportunity with Second Harvest. It was my program coordinator who pushed me to fill out the application without overthinking it. About a month later, I got an acceptance letter. I was very anxious going into the internship, but I pushed past my discomfort. I worked with a mentor, a team of interns, and met with numerous staff members. In the shopping department, we handled invoicing and a scanning project. It was a crucial department, as accurate inventory and fulfillment rely heavily on invoicing. I worked with other interns during distribution

events, which led to many memories. I also had the pleasure of meeting the program services director, the CFO, and the CEO. They provided invaluable insights into their career journey and even extended their generosity by considering bringing me back into the finance department next year. I also reached out to Kieu in finance, who showed me her daily workload and taught me the importance of journal entries and other crucial items, such as insurance premiums. It was definitely a memorable experience, and I hope to return, whether to volunteer or as an intern."

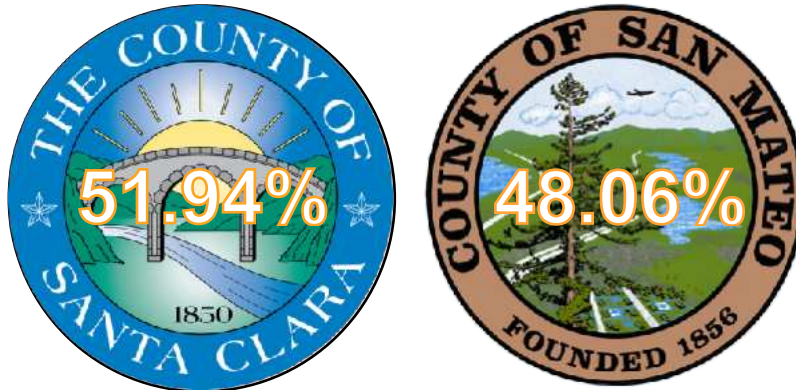

PCF Post-Graduation Job Placement & Higher Education

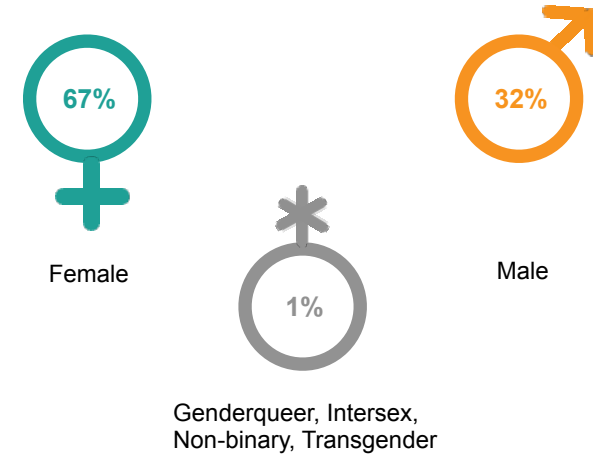

By the Numbers (July 1, 2024 - June 30, 2025)

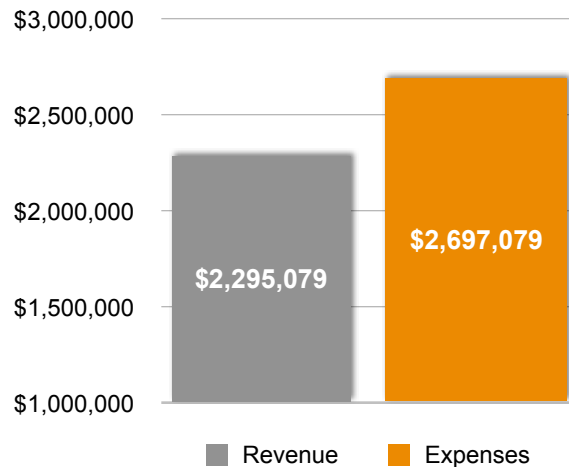
Percentage of Scholars Served by County



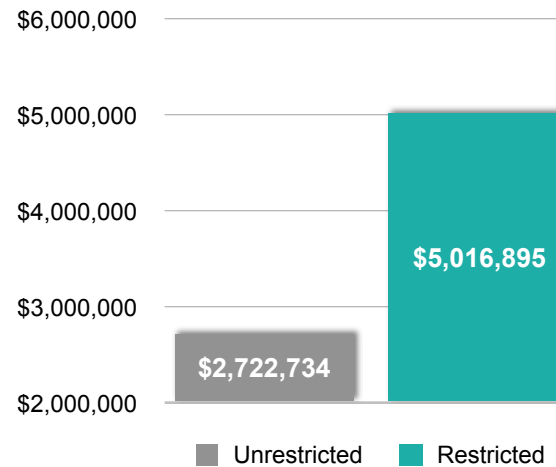
Current PCF Scholars by Gender



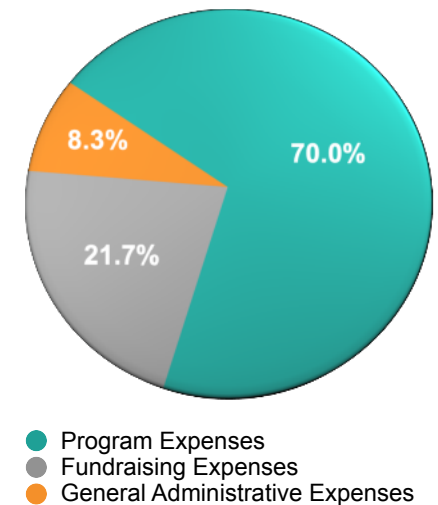
Revenue vs. Expenditures*
